

Bulls/Sox Academy Holiday Camp Sweepstakes
Official Rules

1. **Entry:** To enter, "Like Us" on Facebook and complete entry form between the valid contest dates. Contest begins at 12:01 a.m. CT on November 9, 2012 and ends at 11:59 CT p.m. December 20, 2012. Limit one (1) entry per person. No automatic, programmed, robotic or similar means of entry are permitted.
